IV. REGIONAL CHAMPIONSHIPS - Tami Schaafsma

The Level 9/10 Regional Championships was a four-day meet. It was suggested that the entry fee and gate fee be increased due to equipment costs increasing by 15% and mileage for judges increasing to 62.5 cents per mile.

Due to the increase of expenses for host clubs, a motion was made to charge \$140 entry fee for the Level 9/10 Regional Championships and raise the gate fee for adults to \$20.00.
