## III. OVERVIEW OF REGION 5 CONGRESS

Bobbi Montanari, RACC, thanked the committee for all their hard work at the Regional Congress particularly the set up of the banquet. Concerns were presented to improve the 2008 Region 5 Congress.

- A. Bobbi Montanari will have more contact with the hotel concerning the banquet.
- B. The Regional Administrative Committee is requesting that the 2008 Region 5 Congress be held in Indianapolis and to consider the 2009 and 2010 Region 5 Congresses for the Chicago area.
- C. The RAC recommends that the 2008 Region 5 Congress be held the third or fourth weekend in September. The first two weekends are not advisable because they interfere with the beginning of the fall sessions at most gymnastics clubs.
- D. A video camera projected on a screen should be provided in the sessions where demonstrators are used so that their performance can be viewed by everyone.
- E. A local club should be assigned to be in charge of providing equipment for the sessions.
- F. The RAC discussed honoring all national champions at the Congress banquet. The procedures for including them in the banquet will be discussed at the next RAC meeting in June. The June meeting will also include determining how to get people to the banquet without telling them they are being honored.
- G. Honored athletes and coaches will eat first at the banquet.
- H. The screen at the banquet will be placed in the middle of the room for better viewing.

- I. Have more than one DVD player rather than computers available for the congress sessions so that slow motion, pause and rewind capabilities will be available.
- J. More greeters should be at the registration table. They should be helpful, positive and pleasant.
- K. Electronic versions of the sessions should be made available for purchase.
- L. Lower priced items should be provided at the auction. Items can be auctioned that are not gymnastics related. A list of the items to be auctioned should be publicized prior to the auction.
- M. Mary Lee Tracy will be in charge of publicity on the auction.
- N. Nina Dent will be in charge of the main registration table where presenters, vendors and professional members pick up their Congress information.
- O. Nina Dent will be in charge of the registration table at the banquet
- P. Norbert Bendixen will develop the trivia questions and direct and distribute the prizes for the trivia contests.
- Q. Hilary Carlson is the auctioneer.

## IV. REGIONAL MEET BIDS

The Regional Administrative Committee received one bid for the Level 8 Regional Championships and two bids for the Level 9/10 Regional Championships.

Motion was made to accept the bid from Kris Kowalski of Olympic Academy of Ohio for the Level 8 Regional Championships provided that the bid be adjusted to meet the two gym requirement for the meet.

Both bids for the Level 9/10 Regional Championships were acceptable so a silent vote was conducted to choose the site for the meet. The results of the vote were as follows.
